Qualifications Database of Turkey is the joint and single national platform that ensures the information regarding the qualifications provided in Turkey is accessible, understandable and comparable at national and international levels.

The infrastructure of the Database has been improved by the Vocational Qualifications Authority as the European Qualifications Framework (EQF) National Coordination Point through projects co-financed by the Republic of Turkey and the European Union under the Erasmus+ Program between 2015 and 2018. The Database has been populated with all qualifications provided by the Ministry of National Education and the Vocational Qualifications Authority. The awareness and the use of the Database have been increased. Efforts to include the qualifications awarded by higher education institutions and other institutions and organizations to the Database are underway.

Qualification refers to the official documents, such as diploma, certificate or award, which are obtained when a competent body determines that an individual has achieved learning outcomes to given standards.

Turkish Qualifications Framework, also known as TQF, is the national qualifications framework that defines, classifies and determines the quality assurance principles of the qualifications (diploma, mastership certificate and etc.) awarded at the end of formal education and qualifications (vocational qualification award) obtained through validation of non-formal and informal learning.

The compatibility of the TQF, based on learning outcomes, with the EQF has been approved with the Decision of the EQF-Advisory Group, the competent body of the European Commission, on 29 March 2017.

It is crucial that information about qualifications is publicly accessible in a transparent manner in terms of the mobility of individuals and participation in lifelong learning. Therefore, many European countries are developing qualifications databases complementary to the national qualifications frameworks.

Qualifications Database of Turkey has also been developed as an online platform including general information both in Turkish and English about qualifications within the scope of the TQF provided by different responsible bodies such as the Ministry of National Education, higher education institutions and Vocational Qualifications Authority.

The title and the description of the qualification in learning outcomes, awarding body, TQF and EQF levels, ISCED and ISCO codes, validity date, entry requirements, ways to acquire and relevant web links are available in the Database.



The Database will also be linked to the Qualifications Pillar of ESCO developed and managed by the European Commission. Therefore, the citizens of other countries, as well as the national public, will be able to easily access the information about the qualifications offered in Turkey and consequently the learning opportunities.

Besides, the institutions of other countries where our citizens seek for education or employment will easily access the information transparently presented in English about the qualifications in Turkey, and thereby the comprehensibility and reliability of the qualifications will increase.
